What is the organization's primary exempt purpose?

Sierra Roots is committed to collaborating with chronically homeless individuals to help them make progress in their health, self reliance and action plans to obtain secure and safe homes. We employ a relationship-based approach that identifies individual needs and preserves the dignity of each person.

Describe the organization's program service accomplishments for each of its three largest program services, as measured by expenses. In a clear and concise manner, describe the services provided, the number of persons benefited, and other relevant information for each program title.

28 Manage cold weather shelter operations for Nevada County in Nevada City. The Sierra Roots Weather Shelter is a program in partnership with Nevada County. The Weather Shelter uses a 30-bed public facility in Nevada City as a temporary shelter venue during extreme weather events. The shelter was open for 15 days in 2025.

29 Using a local government grant from the City of Nevada City, we facilitated a portion of their Neighbor-to-Neighbor project. We engaged the homeless population in wildfire prevention to address their safety during wildfires and their role in preventing wildfires from occurring.

30 Provide food, clothing and supplies to the homeless of Western Nevada County: We provided weekly hot meals for homeless participants, using volunteers, totaling 835 meals in 2025. The meals also provided a place to give away clothes, shoes, sleeping bags, and other essential items to participants. This program allows us to cultivate relationships with homeless participants in order to engage them in our advocacy programs and connect them to needed public services. Most participants in this program are chronically homeless, often living in tents in the woods and in other secluded areas.

Using what remained of a state grant and donations, we used our Advocacy program to increase public awareness of homeless issues and increase community engagement in those issues. We were able to produce numerous articles and op-eds in the local paper to increase awareness of local homeless issues.

The Write On program was intended to teach homeless and formerly homeless students to write and tell their stories in poetry, short stories and essays. Once completed, assistant and volunteers were to record and publish the finished works. Unfortunately, the federal arts grant funding this project ended, our Project Director left the organization, and we were unable to complete the project. 11
